Samuel Lim Chairman

Mercylight Animal Rescue and Sanctuary (MARS) has come a long way. We obtained charity status on 8 May 2020, became a Project ADORE Partner on 8

November 2021 and an approved Institution of Public Character

(IPC) from 24 January 2022.

Mercylight is fully run by volunteers, with some volunteers coming almost every day to help at the shelter. We have about 100 volunteers, that keep the shelter running. The volunteers help to walk, feed and administer medication to the dogs twice a day. Those that are not able to travel to the shelter, help in marketing, fund raising and events organised by the shelter.

Message from the Chairman

In 2022, we managed to rescue 32 dogs and re-homed 16 dogs. We take care of about 117 dogs in the kennels, foster care and stray feeding programme.

Through our community engagement programme, we hosted a few organisations to the shelter. This would allow them to spread the message of responsible pet ownership and empathy for animals. The largest group was about 160 students from National University of Singapore.

Through Faith Hope and Charity, we hope the upcoming year will allow us to make a difference to the lives of more animals.



As of 2022, our organization was providing care and support for a total of 120 dogs. These dogs are distributed across various locations, including our shelter, foster homes, as well as strays that we are feeding and attending to.

With a steadfast commitment to rescuing, rehabilitating, and rehoming stray dogs, our dedicated team has made significant strides towards our vision of improving the quality of lives of stray dogs by providing these animals with a second chance at life.

Rescue

Saving Lives and Making a Difference

In 2022, our dedicated team at Mercylight successfully rescued 32 adult dogs and puppies. Each rescue operation, as part of our Trap-Neuter-Rehome/Release-Manage (TNRM) programme, involved swift action in response to distressing situations, such as a dog found wandering aimlessly with gaping wounds or a dog loitering dangerously next to high traffic areas.

Our compassionate volunteers sprang into action, setting up traps and capturing the dog. Some required immediate medical attention, including emergency surgery.

One female rescue was later discovered to be pregnant and gave birth to six adorable puppies in the safety of the shelter.

Our commitment to rescue extends to every dog in need, and we are proud to have made a positive impact in their lives.



Rehabilitation & Rehoming

Providing Second Chances

Mercylight remains dedicated to the rehabilitation and rehoming of stray dogs, giving them the opportunity for a brighter future. Our rescue efforts extend beyond physical care to encompass behavioral training and socialization, ensuring each dog is prepared for their transition to a loving forever home.

16 dogs found good homes in 2022. Testimonials from families who adopted these dogs demonstrate the impact of our work and the joy brought to both humans and canines alike.









Community Engagement & Training

Sharing Knowledge and Empowering Volunteers

Our commitment to animal welfare goes beyond rescue and rehoming. We actively engage with the community and invest in dog behavior and training programs. Through our Community Engagement Program, we provided educational sessions to 160 students from the National University of Singapore, fostering a deeper understanding of animal welfare issues and the vital role animal shelters play in our society.

Additionally, our certified trainers utilize reward-based, positive reinforcement training methods to shape desired behaviors in our shelter dogs. Volunteers invest their time and energy to ensure each dog has the best chance of finding a loving home.





A young dog named Wonder was in search of food in a bustling nursery. The workers at the nursery, armed with brooms and sticks, tried to chase him away, but Wonder refused to leave. Sensing that something was amiss, the nursery reached out to Mercylight, a nearby shelter, for help.

On a fateful day, 19th October, Wonder was rescued by the compassionate team at Mercylight. At just six months old, Wonder's background remained a mystery. However, his behavior indicated that he had likely been abandoned. Remarkably, he showed no fear of humans and already knew basic commands like sitting and pawing, without any prior training from the rescuers or volunteers.

At the shelter, Wonder received daily care and attention. The dedicated team worked tirelessly to correct his minor behavioral issues, such as food aggression and painful play bites. Wonder's situation was not unique; many puppies are impulsively taken in and later abandoned due to a lack of patience and proper training. Fortunately, Wonder was among the fortunate ones who found rescue. But countless other young dogs face the perils of being hit by vehicles, chased by strays, or left to starve as they struggle to survive on their own.



Wonder's journey took a positive turn when he found his forever home. Let's meet the adopters who welcomed Wonder into their family and witness how his training at the shelter helped him adapt quickly to his new surroundings.

"Our decision to adopt a dog was driven by our desire to have a furry companion and make them an integral part of our family.

After moving to a bigger place, we felt it was the perfect time to bring a dog into our lives. Choosing to adopt from a shelter was an obvious choice for us. We firmly believed that shelter dogs deserved a loving home, and Mercylight caught our attention as the first website we explored. That's where we first laid eyes on Wonder.

It was love at first sight when we saw Wonder's profile. We instantly felt a connection and knew he was the one. From that moment, our focus shifted to showering him with love and building a bond of trust. Wonder, estimated to be around six months old, already had some impressive skills. He knew how to sit and paw without any prior training, a testament to his intelligence and adaptability.

Since joining our family, Wonder has seamlessly settled into his new environment. He has gained weight and revels in the ample space he now calls home. He eagerly looks forward to walks, - displaying friendly interactions with other dogs in the neighborhood, regardless of their barking. Wonder's manners are impeccable, thanks to the comprehensive preparation and training he received at the shelter. While we were forewarned about his food aggression, we witnessed his defenses gradually diminish. Now, he allows us to clean his ears and even his eyes without any signs of aggression. His excitement, curiosity, and ability to learn from his mistakes amaze us every day.

Wonder has brought profound changes to our daily lives. He wakes up earlier than anyone else, gently reminding us that it's time to start the day. His playful nature seeks attention, occasionally reminding us of his presence with a gentle nip. Wonder eagerly awaits our return from work, recognizing the sound of our car and warmly welcoming us home from the balcony. Whenever we're away, we miss him dearly and try to return as soon as possible. Wonder's friendly nature has also allowed us to connect with our neighbors as he warmly interacts with both people and their dogs. His friendship with a German Shepherd in the neighborhood is particularly endearing, resembling a canine Romeo and Juliet.



Reflecting on the adoption process, we are grateful for the opportunity to get to know Wonder gradually. We started by visiting and walking him, eventually progressing to a home trial. Witnessing his distress upon returning to the shelter after the trial solidified our decision to adopt him. The process was smooth, and we appreciate the support and guidance we received from the shelter staff who provided valuable recommendations on Wonder's routine and care. We are grateful to Mercylight for rescuing him and providing the necessary care and training. Wonder has become an inseparable part of our family, and we cherish the joy and love he brings to our lives every day. We encourage others to consider adopting from shelters and experience the transformative power of giving a second chance to animals in need."

In the case of Wonder, love and compassion prevailed. From a lost and hungry pup, Wonder found safety, rehabilitation, and a loving home. He serves as a testament to the impact of rescue organizations like Mercylight and the transformation that can occur when individuals open their hearts and homes to abandoned animals. The story of Wonder inspires us to cherish the bonds we create with our furry friends and to continue advocating for the welfare of animals in need.




